THE awards, which recognise and reward the efforts of volunteers, first took place 25 years ago.

Trustpower Community and Communications Advisor Alice Boyd said reaching this milestone has inspired Trustpower to adopt a fresh approach, with more prize money on offer as a result.

Panel nearly ready to report back on dogs

WITH more than 500 responses to a public survey, and having consulted with experts, the Independent Community Advisory Panel considering best methods for dog euthanasia and rehoming will soon begin deliberations.

Regulatory Services Committee chair Councillor Rebecca Amundsen, who has been helping co-ordinate meetings for the panel, said panel members thanked the organisations and volunteers who had spoken to them and shared their views and experiences, as well as the members of the public who responded to the survey or attended the drop in sessions held earlier this year.

The panel was appointed in 2017, and before Christmas members visited the SPCA and Council's Animal Care Facility, met the Animal Services Team and Council's Health and Safety Officer, and were visited by representatives from Christchurch City Council, two Greyhound rehoming groups and Furever Homes.

In 2018, the panel formed and distributed a public survey, which had more than 500 responses, held three opportunities for members of the public to meet them and discuss their views, and met with representatives of Invercargill-based veterinary clinics.

Cr Amundsen said the panel was presently reviewing the results of the public survey and awaiting a report from Massey University before beginning their deliberations.

It was anticipated the panel would provide a report and its

recommendations on dog euthanasia and rehoming to the Regulatory Services Committee at a meeting in April.
