Gingerbread House Competition

The popular Gingerbread House competition is back for a second year and we want you to show us your best creative baking and decorating skills! This wonderful community event is a great opportunity to showcase your talents and build your very own edible house!



All of the houses will be on display in the Cambridge Place Arcade from Saturday 29 December to Friday 5 January 2018.

The categories include Traditional Gingerbread or Authentic Reproduction of a Significant Invercargill Building.

A traditional gingerbread house is where your inspiration leads you. Any structure is allowed in this category: Victorian, colonial, modern, house, barn, cottage – it's up to you!

If you would love to see the Water Tower made out of delicious baking, you might like to consider entering in the Invercargill Building category. This is the ultimate test of realism in the art of building with gingerbread. We'd love to know how much icing it would take to decorate a mini Basillica, or perhaps a scale model of Tay Street? Be sure to include a picture of the real thing!

Entries can be made in either category under the following sections:

- Best By Child Under 10
- Best By Youth 10-17 years
- · Best By Adult
- Best By Family
- Best By Professional
- Best By Classroom.

Entries will be judged on their overall appeareance and design, originality, imagination and use of materials, "fit" in category, difficulty of design, execution and the "holiday spirit" incorporated into the design.

Prizes include more than \$300 in cash and prizes from local retailers and restaurants.

Entry this year is either \$10 or three cans of food, with all proceeds being donated to the local foodbank.

When you have completed your list, hand it in and collect your prize from the Council's Civic Administration Building, or the Invercargill City Library.




Christmas Festival and Market

Choose how you pay your rates invercance.

Online Payments

You can make online payments using either of the following two methods:

- Credit Cards: Visa, MasterCard
- Account to Account: ANZ, ASB, BNZ, Kiwi Bank, TSB, Westpac

A surcharge of 1.7% applies to all credit card transactions (on the payment amount).

Rates can also be paid via the My Invercargill tool available on the Council website, www.icc.govt.nz.

Direct Debit

We recommend you use direct debit to pay your rates. It is easy to set up, hassle-free, convenient, reliable and cost-effective. This method will guarantee you will always pay rates on time and will avoid late payment penalties. You can choose to pay weekly or fortnightly (Wednesdays), monthly on the 15th of each month or quarterly. It is important to note that your rates account/s must be up-to-date before you commence direct debit payments.

You can get a direct debit application form by phoning Council, picking one up at the Council's Service Centres (Esk Street or Bluff), or downloading a form from Council's website.

Automatic Payment, Internet or Phone Banking

You can pay your rates by internet or telephone banking into the Invercargill City Council BNZ bank account. If you pay by automatic payment, you will need to make sure that you contact your bank and adjust your payments to allow for changes each year.

Please note that all properties

have a unique Rate Account
Number (a 6-digit number
beginning with LRAxxxxx/x on your
rates invoice). You should include
this Account Number under the
"Reference" field in your payment.
Ratepayers who own more than one
property should make a separate
payment for each property.

Rates and water billing

- BNZ BANK ACCOUNT:
 02 0924 0019668 02
- PARTICULARS FIELD: The name that appears on the invoice. (12 spaces only available)
- CODE FIELD: The text LRA plus the assessment number.

For example, the assessment number from the rates or water invoice LRA 99991/2 would be entered into the Code field as LRA99991/2.

Cash, EFTPOS, Cheque

Cash, EFTPOS and cheques are accepted at the Council's Esk Street Offices and Bluff Service Centre. Cheques can also be posted to Invercargill City Council, 101 Esk Street, Private Bag 90104, Invercargill 9840.

Rates Rebate

Previously successful applicants for the low income earner rebate will be sent an application form in September. New applicants can pick up a form from the Customer Services' Help Desk from September onwards.
