# **Long-term Plan Consultation Documents** hitting letterboxes this week

Submissions are open for the Invercargill City Council 2018-2028 Long-term Plan, and Consultation Documents will be arriving in letterboxes throughout Invercargill and Bluff this week.

**THE** Consultation Document is your guide to the key projects and proposals Council wants your opinion on from within the Long-term Plan, and includes a submission form.

Submissions will close on 20 April at 5pm, so if you haven't received a consultation docu-ment by 27 March, please con-tact Council on (03) 2111 777 and let us know.

Council's Policy and Strategy Manager Melissa Short said there were some key projects people needed to be aware of in the Consultation Document, and a projected rates increase of 3.96% for 2018/2019.

The Long-term Plan includes proposals and options for five key projects which are: the future of Anderson House, a potential new Arts Centre, the Living Dinosaurs project, developing an alternative water supply, and an additional pool for Splash Palace. Council also wants to hear from the community about whether funding should be increased for ILT Stadium Southland from \$400,000 per year to \$700,000 per year, Ms Short said.

This year, Council has enlisted the help of the Invercargill City Libraries and Archives team, of Keeping Up with the Librarians fame, to create some amazing content about the key projects for Council's Facebook page - www. facebook.com/InvercargillCity-Council/

Ms Short said staff brainstormed to come up with new ways to engage more people, including younger demographics.

"We launched www.imaginein-vercargill.nz in 2017, a website where people shared ideas which were presented to Council to help develop the Long-term Plan, and

where you can now complete a survey on the key issues included in the Consultation Document," Ms Short said.


Entertaining videos and other visual content has also been launched on Council's Facebook page, with the aim of generating conversations about the key projects proposed in this Long-term Plan.

"Feedback posted to Council's page, while not considered formal submissions, will be collated and presented to Councillors for their consideration at the conclusion of the submission period," Ms Short said.

# Have your say on Heritage buildings in the city

A pop-up shop hoping to gather your views on some of Invercargill's heritage buildings is open until this Saturday.

Invercargill City Council Senior Planner Liz Devery said Council was keen to get the public's opinion on City Centre heritage, and the pop-up shop at the former ASB Bank building on Esk Street will be one of the ways they would gather those opinions

Ms Devery said there would be multiple ways for people to show Council which buildings they believed were important at the pop-up shop, includ-

• Photographs of every protected heritage building in the City Centre. People will be able to 'sticker' those that are their favourites.

• A place where people can let Council know what Invercargill heritage means to them.

· A way of voting to find out how people think ratepayers should assist owners of heritage buildings. Is the care of a heritage building just the responsibility of building owner, or does the community have a responsibility too?

Council staff will be on hand to answer any questions people had, Ms Devery said.

**THE** Smokefree Areas Policy was unanimously passed at the Invercargill City Council meeting on 7 November 2017. The policy makes the public areas within the boundary of Tay, Spey, Deveron and Dee Streets (including Wachner Place) smokefree.

Since then, representatives from Council, Smokefree Murihiku, Public Health South, WellSouth, the Cancer Society, Healthy Families, and the Invercargill Youth Council have been working on developing signs for the innercity advising there is to be no smoking.

City Centre Co-ordinator Kari Graber said the signs were a positive way of letting people know smoking and vaping is not allowed in our CBD.

"We didn't want the signs to to all businesses in the CBD with be aggressive and in your face. They're artistic and appealing, but assertive."

Large signs made from metal would be put up in Wachner Place, which will be movable in case of any future development, while the back of a bus would also carry the new signage, Ms Graber said.

Some signs would be installed featuring Te Reo Maori as well. "We will also be providing signs on request to businesses which perhaps have a particular issue with smoking outside their building. That way they have a tool to let people know there is no smok-

ing Another exciting use for the signs has been dreamed up by Public Health South, who will be providing coasters with the sign design

outdoor tables, Ms Graber said. While the Smokefree Areas Policy is a policy and cannot be legally enforced, it is intended to help denormalise smoking to children. Smokers who work in the CBD are able to smoke behind their building so long as they are out of the public eye.

Ms Graber said if businesses required ashtrays to provide for their employees, they could contact council for one to be provided.

Smoking for the purpose of the policy includes e-cigarettes and vaporisers too.

Should this policy work well, it will be reviewed in a year's time and could be extended to other areas of the city.

**THE** Invercargill City Council has launched a new Facebook page called Invercargill Word on the Street.
