2016 Annual Report to the Alcohol Regulatory and Licensing Authority For the period ended 30 June 2016

1. Overview of the DLC Work Load

(a) DLC Structure and personnel

The Invercargill DLC (IDLC) consists of the Chairperson, Deputy Chairperson and two list members. The Chairperson (or Deputy Chair) is the quorum for unopposed applications and can determine applications on his own. Where the application is opposed, the quorum is the Chairperson and two list members.

An agreement is in place with the Southland District and Gore District Councils to enable IDLC to co-opt from their list members. This would be used should the situation arise, due to an absence or conflict of interest, where the IDLC is unable to have a quorum of three members for an opposed hearing.

The IDLC is supported by two staff. One is a full time support officer and the other provides managerial oversight as part of a wider range of duties. The support staff are employed by the Invercargill City Council.

The Licensing Inspector reports to another manager in Council as it is considered that this separation best meets the intent of the Act.

(b) DLC Meetings and Hearings

The IDLC meets once a week to consider and decide on applications. To date these decisions have been done on the papers by the Chair of the IDLC. As at 30 June 2016 no full hearings have been required. This is put down to the facilitative way in which the IDLC seeks to work through potential issues with applicants, and the tri-agency approach with Police and Health.

During the 2015/16 period the IDLC has met to discuss any issues that have arisen from those applications. These meetings ensure that all members are kept up to date and are aware of the types of conditions imposed on applications.

(c) Any Noticeable trends or issues faced by the DLC

The subject of Licensing Fees has been one of the biggest issues in the South. All three Councils involved in the establishment of a combined Local Alcohol Policy faced strong lobbying regarding the increase in fees (to those prescribed as default). While as a percentage the increase was significant there was no recognition that fees had not gone up in over 20 years and that part of the cost of administration was borne by general ratepayers. Each Council agreed to reductions but unfortunately have all used different formulae.

The other key issue is the need for continued education as many people are still applying for either special licences or renewals inside the minimum required notice period. IDLC has applied a "once only" position for each applicant, but only if the other reporting agencies have agreed to us accepting the application and if it is within their capability to process within the reduced timeframe.

2. DLC Initiatives

The IDLC has as per the last Annual Report continued with the separation of the IDLC support staff and the Licensing Inspector to ensure the independence of the decision making process.

The IDLC in October/November 2015 publicised the need for special licences for events to be held over the Christmas/New Year period to be lodged within the required time frame.

3. Local Alcohol Policy

A combined Local Alcohol Policy has been developed by Invercargill City, Gore District and Southland District Councils. It was adopted in May 2016 and is in the process becoming operative (30 August 2016).

4. Current Legislation - Any comment on the Sale and Supply of Alcohol Act

Have no new comments, but refer you back to the points which were raised in the 2014 and 2015 reports. The IDLC would appreciate some feedback on the matters that have previously been raised by us and other DLCs.

5. Any other matters the Territorial Authority might wish to draw to the attention of the Authority

The IDLC is encouraged to see other agencies in the community meeting to discuss concerns around alcohol consumption and harm. The wider support and educational opportunities of "many voices" will play a positive role in helping to deal with these issues.
