Have your say on rules about keeping animals in the city

DO you have cats, bees, chickens or maybe

You might be interested in the proposed Keeping of Animals, Poultry, and Bees Bylaw, which is being reviewed and is open for consultation now.

bylaw regulates how cats, chickens, and pigs can be kept in the Invercargill district. It doesn't apply to dogs.

Strategy and Policy Manager Melissa Brook said Council was proposing a few changes to the bylaw, including changes to the definition of Urban Area within the bylaw so that it aligns with the residential zones in the District Plan.

"There are also two new rules which would prevent the keeping of pigs in residential areas, and would limit the maximum number of poultry which

can be kept in a residential area to 12," Ms Brook said.

Most of the existing rules in the bylaw allow the keeping of various animals within residential areas, as long as those animals don't cause a nuisance, which is when the Council may take

"As the entire bylaw is being reviewed, people are welcome to give feedback on any matter within the bylaw," Ms Brook said

Expressions of interest called for to operate **Anderson** House

PEOPLE, business owners, or other groups are invited to put forward their interest in operating Anderson House.

On behalf of the Invercargill City Council, Venture Southland is seeking expressions of interest in operating one or more services from the iconic homestead.

Significant consultation has undertaken in relation to Anderson House, in which the community indicated it supported the house reopening.

During the Long-term Plan process earlier this year, Council approved plans to undertake earthquake strengthening and make improvements to the building, which



would allow it to be reopened to the public. Improvements include upgrading the toilets, adding a lift and fire safety upgrades.

The expression of interest process, which opened on Monday, is for any party, including trusts or private sector operators, to put forward a proposal about how it would run Anderson House if offered the

Expressions of interest should be well thought through, with information on the proposed operation, how it would be run and funded, as well as outlining the group's skills and governance model.

Any proposal submitted should also

explain how the operation would fit within the context of the wider Anderson Park area and meet the needs of the community. Full details of what is required, including background documentation, is available at www.venturesouthland.co.nz

Venture Southland staff will be available to provide advice to those wishing to submit an expression of interest. All information received will be treated as commercially confidential.

Expressions of interest must be made by 26 October 2018.

• Kōrero - Speak

While there's only a few days left in official Māori Language Week, don't be shy and have a go incorporating these kupu into your vocabulary! te Reo Māori is a beautiful and unique language and we can all strengthen and celebrate it by using it in the work we do.

Meanwhile, Council has been working alongside Te Ao Mārama Inc and Runanga to develop a strategy to further strengthen our relationship with Māori. Previous work has been undertaken by Council staff to identify methods of building our

relationship with Māori and a number of these initiatives (including training in te Reo, cultural awareness and marae visits) have been implemented.

Representatives from the Council and Runanga have had their first hui discussing the strategic plans of both Iwi and the Council to begin determining the areas of common interest and how we can progress these in partnership. Lifting knowledge and skills within staff will assist in building the Council's relationship with Māori.

A strategy, developed in partnership with Māori, will help to ensure the Invercargill City Council meets its requirements under legislation and continues to strengthen its relationship with Māori on an ongoing

However, the i-SITE has moved into a temporary pop-up site at Wachner Place while construction for a purpose-built, portable i-SITE building, also to be located at Wachner place, is completed.

The services offered by the Invercargill i-SITE will remain the same at the pop-up location, however, buses will continue to arrive and depart from Queens Park for the time being
