Mr Marriott informed that Minerva is was purchased by the Athanaeum, and was taken down as an earthquake risk from the Library building and was proposed to be melted down by Council. It has been on long-term loan to the Museum since 1940. Mr Marriott also said that they have found better quality early photograpghs of Minerva from her unveiling, and it is possible that Minerva was originally gold leafed or bronze leafed when she first arrived in New Zealand.

SMAG MANAGER'S REPORT FOR JULY 2021

CATALOGUING AND REHOUSING

The rehousing of the collection has been limited due to staff requirements on the changing exhibition programme, vacancies and the firearms collection. We have advertised for two collection technicians, and will be advertising for a registrar.

COLLECTION

We have engaged Museum Collection specialist Bronwyn Simes to undertake a review of the collection storage requirements for the Southland Museum & Art Gallery. Bronwyn will review the collection areas requiring specialist storage vs collection material which does not require specialist storage.

As a part of her brief Bronwyn will also consult with Jo Massey (SDC) and Jim Geddes (GDC) reviewing spatial requirements should a Regional Storage Facility be required. Bronwyn will also meet with the Iwi Liaison Komiti to discuss the same regarding local marae. Bronwyn will liaise with Andrew Irving, Irving Smith Jack Architects, who is providing advice to the MGG on storage to ensure that we have a consistency of language and spatial requirements.

COLLECTIONS OF NATIONAL IMPORTANCE

Applications for financial assistance to the Ministry for Culture and Heritage will require the Board to present a list of objects which are viewed as of "national importance" – meaning that they have either been responsible for building our story of nationhood and/or their loss would be viewed as a national or international tragedy. As part of the collection storage work we have asked Bronwyn to consider appropriate care for identified items.

A review committee – Jim Geddes (Eastern Southland); David Clark (Lakes District); Gerard O'Regan (Otago Museum); and Bronwyn Simes will be responsible for peer reviewing the list of 100 objects (and their stories). This work will be delivered in August 2022.

FIRE ARMS COLLECTION

Recent legislation changes have required SMAG to install new 6mm fire arms storage. This work has been partially completed in conjunction with the New Zealand Police. Additional cabinets are required which have been difficult to access due to demand and goods being received into New Zealand. We require an additional two cabinets.

SALES FROM EXHIBITIONS

Museums Aotearoa has recently proposed the adoption of a new Code of Ethics. This may restrict the opportunity for an institution to sell works of art from the exhibition space. Traditionally SMAG has hosted a number of selling exhibitions (IPAG have hosted the Annual Spring Exhibition) which has generated income for the Acquisitions Fund.

The proposal has caused some discussion among smaller and medium sized facilities. It is acknowledged that institutions such as Christchurch Art Gallery, Te Papa, and Auckland War Memorial Museum all have retail outlets through which original works of art and craft are sold. A retail operation would not be affected by the proposed changes.

EXHIBITIONS AT HE WAKA TUIA

Planning for 2022 and 2023 is currently underway. The focus of the exhibition programme is primarily from the collections of Southland Museum & Art Gallery and IPAG. In raising the original number of proposed exhibitions from 4 to 12, the team have been able to access a previously planned exhibition, as well as curating several in-house exhibitions.

In order to present those exhibitions, the art collection has been the most easily available as significant research has been undertaken by previous curators. Unfortunately the Social History and Taoka Maori Collections does not currently have the same level of research and work has begun on developing exhibitions which will provide the opportunity to allow the Social History and Taoka Maori Collections to be presented to the community.

In the interim, we have just received the first 500 images from the Elmwood Collection, which have been digitised. This material will become accessible through ICC Recollect Pilot Project. In September the daguerreotype, ambrotype and early glass plate negatives will be digitised, and by November be available online.

Erin Tuhura, who was Assistant Registrar at Southland Museum and Art Gallery for the past 12 years passed away on 30 July 2021.

Jonathan Robert White MNZM actively supported the Southland Museum and Art Gallery since 1976 passed away on 17 July 2021, prior to the opening of his exhibition at He Waka Tuia.

Marilynn Webb ONZM began her working relationship with the Southland Museum & Art Gallery in 1996. She undertook two major solo exhibitions – *In Hodges Wake*, and *From Hodges to Hodgkins to Here* in partnership with SAF, SMAG and DOC. Later she was part of a group of artists who responded to *Rakiura* becoming a National Park in 2000. Marilynn passed away in Dunedin on 16 August 2021.
