6. REPORTS

6.1 SMAG Managers Report for September 2021

A3589375

Mr Marriott spoke to the report and highlighted the following points.

- Browney Simes was currently working to refine the requirements for storage of the collection moving forward. The final report would be completed by 30 November 2021.
- She was reviewing any collection that may have any issues and risks or risks associated with storage in the short or long term.
- Ms Cook requested an update on Koiwi Tangata to be provided at the next Board meeting. In response to this request, Mr Marriot said Te Papa is still working through that system.
- The Museum staff were working to identify 100 objects for the "Collection
 of National Importance" and the final shortlist would be presented to the
 Board in April 2022, after which it would go for external moderation. The
 biggest challenge for this process was the research for individual objects.
- It was confirmed that the original color of Minerva was bronze-green, which
 was identified through research. Minerva would be completed with a coat
 of bronze-green. If exhibited externally it was important to maintain the
 touchups on Minerva's colour coating.
- An update was provided on the deaccessioning process which was first approved by the Board in 1996.
- An update was provided on new staff appointments.
- An update was provided on exhibitions and public programmes, and the direct impact of both Covid19 and the upgrade on Don Street have had on visitor number at He Waka Tuia for August and September.

Moved Cr Amundsen, seconded Mr Eagles and **RESOLVED** that the report "SMAG Managers' Report for September 2021" be received.

7. FINANCIAL REPORT

Mr Craig spoke to the report and highlighted the following points.

- There was a strong cash position.
- Term deposit renewal would be due in March 2022.
- The reimbursement to Toni Biddle was related to the previous financial year.
- The levels of income and expenditure for the Board were lower than the
 previous financial year. Current financial year grants were received from
 the Southern Regional Heritage and were to fund only the collection. The
 SMAG Board was no longer managing any operational costs.
- No major movements in reserve accounts other than receiving interest.

Moved Cr Ludlow seconded Cr Soper and **RESOLVED** that the Southland Museum and Art Gallery Trust Board;

- 1. Receive the "Quarterly Financial Report for the 3 months ended 30 September 2021"
- 2. Approve the payment for authorisation.

8. GENERAL BUSINESS

Mrs Henderson tabled a document on behalf of the Friends of the Southland Museum and Art Gallery.

Mrs Henderson read the document to the Board and requested to move a motion.

Note: Ms Cook raised a Point of Order and stated that this was not a matter to be discussed in the public session of the Board meeting.

Mrs Henderson stated that the document could be tabled to be received and that the decision making could be referred to the next Board Meeting.

The Board discussed the matter and asked Mrs Henderson to read her recommendation.

The recommendation read:

"The current Trust Board needs to determine the goals of any restructuring. We need to engage with a lawyer who has expertise in this area, to prepare a draft that you can consider and improve. Then we can discuss the proposal with community members. Friends of SMAG do not believe the current proposal will provide better governance and documents are confusing and contradictory. This is on behalf of the committee of Friends of SMAG."

Cr Ludlow allowed the Item to be tabled.

Move Ms Cook, second Cr Soper and **RESOLVED** that the item be tabled.

Note: Cr Menzies raised a Point of Order and stated that the Trust Deed that Mr Marriott provided to the Board for review was a public excluded document. She also noted that the Board had not agreed to share that document with any outside parties such as Friends of SMAG.

Cr Ludlow clarified that items discussed in a public excluded session or a workshop should not be discussed with any other parties.

Note: Cr Soper raised a Point of Order and stated that the item was tabled and the Board could not discuss this matter further.

Cr Ludlow agreed on Point of Order raised by Cr Soper and closed the item.

9. CORRESPONDENCE

9.1 Late Item - A Letter from Audit New Zealand

The letter from Audit New Zealand was tabled which formally advised the Board they were running behind schedule for their audit process.

Mr Craig informed the Board that the Charities Services extended their deadline to file the annual returns for the audit until 31 May 2022, to account for the delayed audit process.

MUSEUM TRUST TO BE DECAPITATED

The existing Southland Museum and Art Gallery Trust Board (Inc) SMAG, is to be restructured and there is a proposal to radically change it's Constitution and rules. This is to be considered on Thursday 4 November 2021.

The Friends are not to be included in the new board. A previous board opted to create a position for a Friends representative as it was recognised at the time that the Friends played an important link between SMAG and the Southland Community, widening the contact SMAG had with the public-through monthly events etc.

The Friends worked with and supported staff, brought members of the public with heritage and artistic interests into the Museum, and contributed a significant number of volunteer hours to SMAG.

What the principle outcome seems to be is that the three councils effectively are turning SMAG into just another council department rather than the independent body it should be. This seems to be at odds with the general principal that the Trust is a registered charity governed by a completely independent and impartial board of trustees.

Currently the SMAG board is made up of up to nine members, three appointed by the ICC, two by the SDC, one by GDC, one by Friends of the Museum, one by the Tangata Whenua and two by consensus of the ICC and SDC appointees.

This proposal to effectively revoke all current nine SMAG trustee positions and appoint the three Council chief executives as interim trustees who shall then establish an appointments committee who will then make five appointments to the Board. It is hardly being representative of the wider community when the three CEOs

establish an appointments committee who will then make five appointments. This leaves the door wide open for perceptions of cronyism and 'stacking the deck'.

A key element of a democracy is checks and balances and that the power to make appointments in the case of SMAG, like any other public entity, is vested across a broad spectrum of the community and NOT placed in the hands of a small group who could be seen to be less than representative of the community.

The Friends of the Southland Museum and Art Gallery want greater inclusion of the wider community in a democratic process. The Friends also deserve to be recognised and continue to be involved with Board activities, and to work together to create a Museum which will celebrate our heritage and inspire creative responses to our many future challenges .

Bronwyn Simes has completed her review of the collections of SMAG, as well as other potential entities for her draft report which is due in early November..

COLLECTIONS OF NATIONAL IMPORTANCE

Research has continued on identifying potential 100 objects for "Collections of National Importance". The working draft of the list has been updated.

Koiwi

Jamie Metzger (Te Papa) and Amber Aranui (Te Papa) met with me via Zoom on 17 November.

Previously Amber had been working with previous Team Leader – Collections on a report regarding Koiwi held at the Southland Museum & Art Gallery. A draft report has been prepared which requires input from the Te Papa Repatriation team. The team was supposed to have been in Invercargill prior to the last Covid-19 lockdown but their trip was postponed.

The team require access to David Teviotdales field diaries, as well as any other correspondence we have relating to Koiwi and some early archaeological digs. It is proposed that Te Papa will undertake this work on site in Invercargill prior to the end of the year – subject to any Covid-19 restrictions applied to Te Papa staff.

Following the completion of the report this will be circulated to the lwi Liaison Komiti for review prior to being distributed to the Board.
