3. Public Forum

3.1 Brian Rowe – Oreti Sands User Group

Mr Brian Rowe was in attendance to speak to the meeting on behalf of the Oreti Sands User Group. A copy of his submission was circulated among the councillors to be read in conjunction with his presentation. He noted that he had queried whether forestry zone 2 had been included in the tender document C1175 Forestry Management of Sandy Point, that the response he had received was that the only forestry which could occur at Sandy Point would be in relation to the 2013 Sandy Point Domain Management Plan, and that

any alterations would be brought through revisions of the Management Plan due early 2024. He said that forestry zone 2 was included in the Sandy Point Management Plan of the Sandy Point Domain Management Plan.

He said that he had noticed an increase of dog walkers soon after the closure of the golf course. He said that Council had maintained it along with the Southern Institute of Technology (SIT) for a number of years, and that the grass had been used for baleage. He said that he had emailed Council's Parks staff about the increased degradation of the course and tracks due to invasion of lupines, and that the response he had received was that it was a low mow area.

He said that he had heard that the golf course would be closed down and that it would be used for forestry and carbon credits. He said that he created an Oreti Sands Facebook group, which had a reach of over 3000, and had conducted a poll among them on whether they were aware that Council had carried out a consultation on the future of Oreti Sands and the whole of Sandy Point domain for the next 30 to 50 years in 2022. He said that 91% responded in the negative and that the only media reporting on the consultation had been three months after submissions had closed. He said that early this year, he had walked around most of the track with a Council staff member and that the staff member had informed him that dog walkers had said they were happy with the track. He said that the staff member's polling indicated a 100% acceptance however, the response he had received on another poll created among the Oreti Sands Facebook group indicated that 88% were unhappy with only the track.

He said that he had been advised that the new Masterplan would be completed by 2024 and that the staff member had suggested that the Masterplan would be re-opened for consultation to stakeholders. He said that the Oreti Sands User Group being a stakeholder wished to submit that Oreti Sands be kept opened for multiple users, and in the nature of a golf course such as wide areas of land protected by forested areas and clearly defined tracks. He said that there would be opportunities for organisations such as Active Southland and Disabilities Resource Centre to make it a recreation hub.

He said that the main barrier was a lack of maintenance particularly in reference to invasive plants such as lupines, broom, and gorse. The bulk of the lupines were contained within forestry zone 2 and that a couple of fairways were choked by them. He said that they were working with an expert in land reclamation to look at clearing the lupines and other pest plants at zero cost to the ratepayer. He said that the stumbling block was that Council's Parks department would not allow lupines to be cleared and tracks reestablished within zone 2.

In response to a query about what the Oreti Sands User Group wanted to be done, Mr Rowe said that he had heard that the golf course was closing down and had asked whether volunteers could fix the problem, mainly with the lupines. They had found a contractor who would do it however, Council's Park department were not permitting them to do so.

It was noted that only the golf club would be closed and not the course itself as it was a multiuse area.

In response to a query about how the cost of maintenance could be managed without it falling on the ratepayers, Mr Rowe said that contractors could mow the area for

baleage which would generate revenue that could then go towards the maintenance of the area.

In response to a query whether the maintenance of the area by Council was not up to standard as a golf course, Mr Rowe said that from 2018 to 2020 Council had maintained the area up to the standard of an actual golf course. Contractors also used to take baleage from the fairways however, when the contractors stopped doing that, the lupines took over the fairways.

In response to a query whether the request was for the invasive plants to be better managed so that the area could be used for multi-purposes, Mr Rowe responded in the affirmative.

In response to a query whether the Oreti Sands User Group also proposed that this area be turned into an official dog park, Mr Rowe responded in the negative.

In response to a query about who would pay for the re-sowing of baleage, Mr Rowe said that the contractors would pay for it.

A query was raised to Council staff whether the maintenance of the area to a better standard had been costed. It was noted that costings had not been done and that it would come through after the Masterplan and Reserve Management Plan process was completed. It was noted that better options would be provided through the process. This would take place late 2023, that it would also go out for consultation, and that all stakeholders would be contacted again.

In response to a query whether that area had been used for baleage in the past, it was noted in the affirmative.

The Chair thanked Mr Rowe for taking the time to attend the meeting.

Two Youth Councillors will be in attendance to speak to this report and provide a rangatahi insight to their view on how Council could be helping to combat Climate Change. An additional two members will present on their recent trip to Wellington for the Festival for the Future.

Background

At the second meeting of The Invercargill City Youth Council this year, the Mayor asked Youth Councillors to consider climate change. At their May meeting, Youth Councillors held an exercise on where members sit on a continuum and looked at what reduction practices Council has implemented (refer 2023 03 28 – LTP Workshop – Region and Environment).

The Youth Council has 23 members in 2023. Members are made up from school representatives, including Te Wharekura o Arowhenua, and community representatives. Youth Council meet 4-weekly on a Wednesday afternoon between February and October, with committee meetings on alternate fortnights.

Update

Climate Change

On 24 May 2023, Youth Council took part in an exercise to highlight the different positions on the climate change continuum, from those holding climate change of high importance and wanting to see change in practice/resources/production to those who did not.

Included here is the photo of this activity with the far left being the high-importance end of the continuum and the far right being the low-importance end of the scale.



Below are the comments and questions that were discussed at the May Youth Council Hui. Members are working with Council staff to establish answers to some of these.

Many of those who weren't supportive of climate change action mentioned information fatigue as a main cause, highlighting that they always wonder if their efforts can really make a change. They clearly articulated that they care about the negative impacts climate change has, however they are unsure of how to navigate this and whether they can make a difference.

An update was provided on Council's work around climate change and initiatives that have been made as a city towards reducing emissions.

This raised numerous questions from Youth Council:

- Emission reduction activities aren't reflective of the big emission contributors why?
- Why is Council doing this when Invercargill and NZ are only a very small emissions contributor in the global perspective?
- What are the financial implications of the reduction actions, specifically, how are these being balanced with costs to ratepayer? Also what is the cost of mitigation?
- Does tree cutting in Queens Park impact on this? How?
- What will ICC do to help the public/individuals reduce their emissions?
- Will ICC consider offsetting their current emissions?
- What are the outcomes of digitization as a reduction strategy? Why is Council doing it?

The Youth Council were interested to know about how Council were talking with other organisations or groups around emission reduction, as they were aware that there are many to reach out to.

Youth Councillors urge Council to explore more public awareness measures for climate change and influence/support greener practices, bringing environmental wellbeing to the community.



A new track counter was installed at Oreti Links Ex Golf Course, Sandy Point in mid-May. This was installed to increase understanding of user numbers at this popular multi-use area and venue. The data indicates there have been around 6000 visitor counts to the site over the initial seven-week period of early winter. Further analysis will be undertaken to determine how many individual visits this represents.




Fig 2: Track and Trail Count Premier Park

The slight decline in user numbers reflects the cooling weather of early winter.

Forestry - Sandy Point Domain

A transitional plan was presented to Parks and Recreation by new forest management company John Turkington Limited (JTL). The plan summarised their understanding of forestry operations in the past and outlined how they propose to carry out forest management operationally moving forward.

Key points:

- To set forestry up to optimise profit in the long term, more operational investment in silviculture is needed now, to create an ability to minimise 'thin to waste' and enhance 'thin to harvest' capabilities.
- Stocking rates are assessed as extremely high in Sandy Point based on industry standards. By reducing stocking rates with future planting, both planting and thinning costs will be reduced and long term potential revenue increased.
- The forest, under our current approach, is currently programmed to be harvested quicker than it actually can grow. By reviewing our approach, reducing the harvest areas over the next 5-10 years our operator will create a more sustainable forestry resource for future generations. The consequence is a potential reduction in short term revenue with the greater likelihood of increased revenue in the medium to longer terms. Depending on market price fluctuations this may still stay within the forecast.

An Annual Operational Plan will be presented to Council Staff for approval which will set out what site preparation work, planting and pruning will be done within existing forestry areas to continue the forestry operations. Forestry Planning is intended to align with the current Sandy Point Domain Management Plan and Forestry Management Plan.

Pest Plant Control - Motupōhue/Bluff

Pest plant control focussing on broom and gorse is well underway by contractors in Bluff. Various sites around the community include Robinson Park, Foyle Street Reserve, Slaney Street Reserve, J. G. Ward Reserve, Bluff Cemetery and Bluff Hill Reserve.

Russell Square Playground Development

Following feedback from the community and issues with trees in decline, upgrades to the playground began in 2022. We have completed stage one of the development, which included:

- Removal of large declining poplar trees and replanting with smaller flowering trees that produce less leaf litter.
- Fencing to provide a safe space for those with neuro-diverse children to play.
- Replacement of an older seesaw with an all-inclusive model and safety surface renewal.

Stage Two has almost been completed, including:

- Installation of a large picnic table in the barbeque area and a drinking water fountain along with associated paving.
- Installation of a donated seat and landscaping has been completed.

Venue Booking System

ICC has signed a contract with Attekus, an Australian based company who run a venue booking system which links with TechnologyOne. The booking system will be rolled out across Leisure and Recreation with 15 sites across the various business groups being moved onto an electronic platform. This will provide better visibility and transparency of available venues for the community and an improved internal and external customer experience.

Venues and Event Services

Venues are seeing good sustained growth across its current portfolio. The Civic had one cancellation, Don Mclean, due to weather. Over 600 rangatahi were involved in ShowQuest and over 550 attended Circus Quirkus, a free event run by the Lions Foundation. Preparation commenced for the annual Rotary Book Sale.



The Scottish Hall continues to grow in popularity and occupancy with the community hosting a variety of events, classes and business activities.


The Community Access Programme is receiving excellent feedback from the community giving clear and easily understandable guidelines in how they obtain a community discount on venues. The programme is being applied at present.

The Venues team have taken over ticketing of the Southland Stags and has now also opened The Civic Theatre box office for four hours per day Monday to Friday. This has enabled an increase in level of service for the community by providing greater ticketing purchasing options without additional cost.

Looking Ahead

June will see another strong month across all venues with a variety of events and activities from community, to touring and the increasing function undertaken at The Civic.

Season tickets will be placed on sale for the Rugby Southland season and tickets will now be available during the day from both The Civic Theatre and the Customer Service Team. The Civic Theatre will be open from 11 am to 3 pm Monday to Friday to support both customer service when it's busy and also as another option for ticket purchasing.

At The Civic the annual Pipin' Hot will take place along with several touring, community and international events.

The Scottish Hall continues to grow in popularity and initial thoughts have begun looking at how we can enhance the customer experience in the space and tell the story of its importance to the community.

June will see the commencement of using the Rangaranga Programming Framework developed to work across the organisation to align cohesively collaborative opportunities and events. Its first project will be UPSTAGE – A Festival of Cabaret. This will be presented to the working group for feedback and to look at how other parts of the business can be involved to benefit their specific business.

Aquatic Services

Aquatic Services in May was relatively quiet post-school holidays. Although participation was up from April, it was down from March and February. At the end of May, the change in weekend hours and changes to staff rosters were implemented. The transition to the new hours went well with no complaints received or any issues identified.

Participation and Visitor Stats

There was an 11% Increase in participation in May from April. May 2023 participation was approximately a 10% increase on May 2022 and an 8% increase on the last 5-year average.

Café and Retail

The café in May had an average spend per participation of \$1.08, the benchmark for a café in an aquatic facility is \$0.80 per participation. The café is operating consistently well with revenue being mostly in the \$36,000 - \$42,000 per month, May revenue was 13% lower than April.


Retail sales are still performing well, however, May revenue was the second lowest so far this financial year, with only August 2022 being lower.



Library Visits




Visitor numbers remain steady with use across all days of the week.

Programmes

Nibbles and Nimble - Community event and app launch - 2 May 2023

The Library partnered with Well South to organize a falls prevention event targeted at individuals aged 65 and over. The event introduced the "Nymbl" app. The app is designed to be an interactive way to improve balance and cognitive function for seniors, it is fully subsidised by ACC. We saw an excellent turnout due to targeted advertising and promotion of relevant programming at the library and with our partners. The event exceeded expectations and attracted many new attendees to our strength and balance group

May the Force be with you - activities and quiz - 4 May 2023

To celebrate "May the Force" day, we hosted various activities for children, youth and families including a photo booth and a quiz night. This was an attempt at events that people needed to pay for to attend. We set the attendance fee reasonably low (\$10 per table of up to 6 people) to make sure the cost was not a barrier to participation. The community support was overwhelming, with all tables filled and new library memberships acquired. Participants provided positive feedback, expressing their enjoyment interest in attending future quiz nights.



Rangatahi in Tech Youth Week event - 15 May 2023



One Foundation approached us to host tech activities for rangatahi during Youth Week. We organised a range of engaging activities that involved technology, such as 3D presentation and demonstration, stopmotion animation, VR experience and

gaming, and robots. It was a pleasure to see a diverse range of participants, including Maori, Pacifica, and other ethnicities, and to share our library services with them.

Edward Bullmore: A boy from Balfour (May 13 - June 18 2023)

Public Programmes and Outreach (822 participants)

Kapow: The Great Comic Art Show at Whare Taupua (May 4 – June 3)

He Waka Tuia collaborated with GreenLight Innovations and Arts Murihiku to deliver this exhibition which celebrated the exciting genre of comic art through a local, national, and international lens. Drawing stations and reading areas were set up throughout the exhibition for visitors to enjoy.

Workshops with Michel Mulipola (June 7)

Southland Museum and Art Gallery Collection

The packing of the Pasifika collection has now been completed. The Armoury collection has been photographed, and the packing of sword, medals and silver collections are nearing completion. No items have been tagged for Consider for Deaccessioning (CFD) in the Armoury and Pasifika collections.

With the focus still on Social History, the team have been steadily packing the collection and highlighting additional "Hero" objects, or objects which could/should be exhibited in the future. The Campbell Glass Plate collection which should date from 1888, has identified images from the early 1860s. The 6,000-plus glass plates associated with this collection are currently being cleaned and rehoused in preparation for digitisation.

Anderson House

Following discussions with representatives of the Anderson House Trust, a number of pieces of furniture, including Sir Robert Anderson's desk will be placed on long-term loan to the house.

Industrial Items

The Thornbury and District Museum has reviewed the industrial collection and has indicated that the selected items fit within their collection. They will be relocated to Thornbury in July 2023.

Pacific Islanders Advisory and Cultural Trust Inc (PIACT)

Six items from the Pasikifa collection have been placed on short-term loan to PIACT.

Southland Daily New and Southland Times (bound collection)

The Southland Museum and Art Gallery Trust Board have endorsed a proposal for the bound volumes of newspapers to be relocated to Invercargill Libraries to enable a long-term digitisation project (Papers Past) to include this material. The collection will be treated for pests, via freezing and will be relocated to the Library in early August.

Consider for Deaccession (CFD)

No additional items have been tagged CFD during May. This process will occur during June when the Social History collection is packed.
