

Blind Citizens – Southland Branch wish to bring to your
attention the demise of the audio dual controlled pedestrian
crossing signal situated on the corners of Queens Drive and St
Andrews Street.

History: In 2014, Eddie Cook (who then worked for ICC), designed, and installed a new style of audio controlled pedestrian crossing signal which enabled pedestrians who wished to cross the street to choose one of two speeds they could cross the road. One could either cross the street at the same speed as at any other pedestrian crossing in the city or one could choose to walk at a slower speed. Eddie considered this style of pedestrian crossing signal beneficial for older people, young children, mothers with prams and disabled people. When this new crossing pedestrian signal was officially opened there was a fanfare of media attention from

newspapers, radio and even national TV news items were broadcasted at the time. We the Invercargill blind community felt this new audio dual pedestrian crossing signal was helpful for many vision impaired, blind, and deafblind people to cross the road safely. We were informed that this dual controlled pedestrian crossing signal was a trial but no time-frame was given on when a decision would be made to continue using this style of controlled pedestrian crossing signal permanently or discontinue using it.

Shortly after this trial commenced, Eddie Cook left his employment with ICC and started a new job with Kiwi Rail in Wellington. Since Eddie's departure from Invercargill, the audio controlled dual pedestrian crossing signal has continued to be used in this one intersection of Invercargill.

Concerns: Over the years our members have noticed a deterioration in the quality of sound of speech within this audio dual controlled pedestrian crossing signal. When it was first installed the speech was very clear and even people who were deafblind were able to understand the instructions. One of our members, Victor West has on numerous occasions, complained to ICC staff about the quality of sound within this style of audio pedestrian signals but all he is told is that this is still a trial. We express our concern that Council has not been maintaining this audio dual controlled pedestrian crossing signal for many years and we hope that Council will investigate the best way to maintain this signal so in the future, people can continue to choose the speed they need to walk across these roads.

Trials should be short-term, allowing professionals to research public attitude and analyse both positive and negative elements within the trial. To run a trial for nine years does appear fruitless because if Council considers this style of controlled pedestrian crossing signal worthwhile, then you would want to rollout this style of pedestrian signals on other intersections, once those audio pedestrian crossing signals need replacing.

Over the past nine years, more physically disabled people are visible in our communities. They would benefit from these dual pedestrian crossing signals like those of us from the Invercargill blind community. We hope that Council will remove the trial concept of using this style of pedestrian crossing signals after so many years and begin to improve the sound quality of the current Audio Dual pedestrian crossing signals so people can continue to use these crossings as they are so much safer for us to use.

Another issue you need to consider is that Invercargill has more traffic driving around its streets than we did nine years ago. With an aging population and busier roads, the idea of rollingout audio dual pedestrian crossing signals is more important today than it was nine years ago.

I understand Victor West has booked to speak on this matter at the Council's Infrastructure Committee Meeting on the 10th October.

## 4. 2023 Youth Council Update - Climate Change and Vaping Survey Results Report

Mr Liam Calder, Ms Emma Pope, and Ms Emma Wills were in attendance to present the report

Ms Wills spoke about questions posed by Council around climate change and noted that for better involvement youth need to be included in decision-making. If Council wants the Youth Council's ideas on specific areas of climate change, they would prefer to have a workshop with Council. They want to see Council focusing on good news stories and positive information. In relation to greener practices, the Youth Council was pleased to hear about the environmental options that were chosen for public parades.

Ms Pope spoke about vaping survey results and explained the results. It was noted that the Youth Council believe in the expansion of smoke-free the CBD boundary and this expansion may include school zones. They would support for Smoke-Free 2025. She said it would be useful to see more smoke-free and vape-free signage within the CBD and use Council's social media platforms for the awareness of smoke-free zones. Further she said, the Youth Council was interested to know what measures exist when specialised vape stores want to be open in the city's smoke-free zone.

Mr Calder spoke to the report and noted that the Youth Council would be opening its nominations on 15 September 2023 for the 2024 Youth Council Elections and nominations would close on 15 October 2023.

In response to a query about the best social media channels to get youth opinions on Council projects, it was noted that Facebook and Instagram would be best. Council needed to find out what elements would attract youth to these engagement programmes.

In response to a query about the Youth Council's concerns about having vape shops in the CBD and what they could suggest to change this, Ms Wills said she would take the question to the Youth Council for their opinion.

In response to a query about what mechanism was used to get 164 responses to this survey, it was noted that they sent the code for the survey through the youth councillor's to participants.

In response to a query, if the youth councillors felt the survey result be different if more people had participated, it was noted that if more people answered the survey it could be more reliable but they think the information through the survey was valid.

In response to a query about whether they believed there was an increase in vaping, it was noted that according to their personal experience, they believed there was an increase and it was becoming a huge problem at schools.

## 8. Sandy Point Domain Masterplan and Management Plan A4772834

Ms Caroline Rain, Ms Cassandra Horton and Mr Chris Bowen presented the report.

Ms Rain provided an overview of the report and noted that the Masterplan would provide a long-term vision for how the Domain could be used in the future. In this process, Council officers engaged with the community to finalise the Masterplan.

Ms Horton and Mr Bowen took the Committee through a presentation for the Masterplan.

Ms Horton said that in order to understand the strategic direction, engagement sessions were conducted with multiple partners, stakeholders and Mana Whenua. Over 1,500 responses were received through the residents' survey. Leisure and recreation, native vegetation, pest control, safety and security were key findings through the engagements.

Mr Bowen explained the existing situation of the Sandy Point Domain and the overarching strategy including enhancing recreational offerings, promoting visitor

experience, and building environmental resilience. At this stage, the Masterplan would focus on 10 year timeframe.

In response to a query that the Masterplan contains a presumption of closing access to Oreti Beach for vehicles, Ms Rain said no and explained that the beach was out of scope of the Masterplan and any access changes here would need to be addressed collaboratively with the Department of Conservation, Environment Southland, Iwi, Southland District Council, and roading through a Memorandum of Understanding.

In response to a query if Coopers Creek would be covered by the Management Plan, Ms Rain said yes.

In response to a query about issues at Coopers Creek, it was confirmed that those specific issues would be addressed by the Management Plan.

In response to a query about pest control, it was noted that under the current Management Plan, there were pest control programmes for predatory and ecological plant species and it was expected that more species would be identified in the next Management Plan.

In response to a query about document restructuring for the stakeholders of Coopers Creek who have a licence to occupy, it was noted that there was no immediate work on that area because Council was waiting on feedback on disputes in that area.

In response to a query about road closure down the side of the river, it was noted that if current trends continue, it is important to develop the idea of secondary access through this Masterplan. The data collected on this matter indicated that it required having different management options.

In response to a query about cost, it was noted that the Management Plan would provide the costs for the next three years. The Masterplan is the only focussed on the vision.

It was noted that after Council endorsed the Masterplan it would enable the consultation process for the Management Plan to begin. This process contains two stages, initial written submissions for what people would like to see in the Management Plan then the Management Plan would be drafted accordingly and the draft would then open for written submissions as the second stage of the process. The process needs to be conducted according to the Reserves Act.

In response to a query about the best way to engage with people, it was noted that engagement would be planned using multiple avenues. The consultation plan would be presented to the Committee at a later stage.

The Committee had a robust discussion on document restructure around licence holders in Coopers Creek and decided on an amendment to the resolution adding a fourth recommendation.

The Reserve Act has a two-month period requirement for the consultation for the Management Plan, which would be dealt with at a later stage.

In response to a query about delaying the process for the reclassification consultation and the new museum design going into lot 2, Ms Erin Moogan said that the process was paused because of not having certainty about what actually that space would be required for. In terms of the timeframes around this, it would take four to six months, construction would not start during this period. The change process is particularly low risk. Further, she said, when presenting the concept designs, the possibility of stepping into the additional space in lot 2 was noted and that there would be a requirement to address this under the reserves process.

Mayor Clark raised a point of order regarding the statement made by Rev Cook by challenging another councillor who asked for guidance under the law and Cr Pottinger supported the point of order. The Chair noted and upheld the objection.

In response to a query about the timeframe for construction and possible delays, it was noted that the Project Management Office were continuously reviewing the progress and the timeframe.

It is understood this could provide sensitivity to issues in their community, but ultimately hearing decisions are based on the law.

Cr Soper said it would be valuable to the process.

Cr Kett recommended the representatives have required knowledge or qualifications for S&SA 2012.

- 3. Consideration to be given to advertising to members of the public to apply to be a member of the District Licensing Committee.
- 4. All in agreement that meeting with Regulatory Agencies and Licensing Inspectors was a valuable exercise. An annual meeting with regulatory agencies would be beneficial. Once a year with Inspectors would also be enough, unless there is a high turnover of staff then the DLC would consider another meeting.

# **Purpose and Summary**

Shortly before Parliament rose, the Government introduced a Bill seeking to lower the voting age for Local Government Elections. This was in response to the Supreme Court making a declaration of inconsistency against the New Zealand Bill of Rights Act for the voting age being 18. This paper invites Council to consider making a submission on the Bill and if so whether it is for, against or neutral.

# **Recommendations**

The Committee:

- Receives the Report "The Electoral (Lowering Voting Age for Local Elections and Polls) Legislation Bill".
- 2. Confirms that Council does/ does not wish to make a submission on the Bill.
- 3. Confirms if a submission is to be made whether that submission is For/Against/Neutral.
- 4. Delegates to Mayor/ Crs **xxx** to approve the Submission.

## **Background**

On 21 November 2022 the Supreme Court of New Zealand released a decision that made a Declaration of Inconsistency against the Government relating to retaining the voting age for all elections at 18.

This Declaration was made under provisions of the New Zealand Bill of Rights Act 1990 and triggered a process that required the Government to respond.

As part to the Government response the initial plan was to introduce legislation to Parliament that would lower the voting age to 16 for National and Local Government Elections.

However, to change the voting age for National Elections the Bill would need a super majority of 75% of all Members. Both the National Party and Act Party indicated they did not support such a change, meaning the super majority could not be met.

However, to make the change to the Local Elections Act 2001 it only requires an ordinary 50% majority.

On 15 August 2023 the Minister for Local Government introduced The Electoral (Lowering Voting Age For Local Elections And Polls) Legislation Bill (the Bill), which will lower the voting age for Local Elections to 16 years of age and provides the mechanics to make the change.

It had its first reading in Parliament on 29 August 2023 and was sent to the select committee. The submissions opened on 8 September 2023.

The opposition at the first reading spoke against the Bill.

In the event of a change of Government at the next election it is likely that this Bill will not proceed, based on statements made by both the National and Act parties.

However, in the event the current Government is returned or National and Act decide to proceed further with this Bill then it is recommended that a submission be made to ensure the views of Council are known.

One key issue with the Bill is that it retains the voting age at 18 for Licencing Trust Elections. This means for much of Invercargill<sup>1</sup> there will be a two-tier voting paper, with those over 18 able to vote for all elections, and those under 18 able to vote for Council but not the Invercargill Licensing Trust (the Trust).

# **Issues and Options**

# **Analysis**

Regardless of where this Committee decides to be in terms of supporting or not, there are technical issues that should be submitted on in terms of the voting age difference between the 16 years for Council and the 18 years for the Licencing Trust and the impact that will have on our election administration.

The Bill creates a number of practical implications for Council in the running of the local elections. The key issues identified relates to the Licencing Trust.

Invercargill is home to one of the largest Licensing Trusts in the country, the Invercargill Licencing Trust has been part of Invercargill since 1944.

By lowering the voting age from 18 to 16 for Council but retaining the voting age for the Trust at 18 this will create confusion amongst the public as to who can vote for who and what.

There are already a number of issues each election cycle with people wishing to vote for the Trust but are unable to as they lie outside of the boundary (a boundary that has not been changed for many years and therefore bears no real semblance with the urban boundary of the modern Invercargill City) and this will only add to the confusion in the public.

While we can understand the Policy reasons for this decision (to retain the age at 18 for Trust elections) given the legal age to purchase alcohol is 18, there are a number of practical implications that will directly impact this Council and our community.

Chief amongst these will be the various incarnations of the voting forms that we will need to prepare. In addition to current form, another form would have to be created for an Invercargill City youth voter, who can vote for the Mayor, Council, and Regional Council only and have the Trust nominations removed. This is likely to add to complexity to printing and potential cost.

It will also complicate the issuing of special votes, especially around those who turn 16 after the roll closes but before Election Day.

However there is nothing that is not insurmountable in terms of the voting forms. The number of birthdays between the close of the roll and Election Day are likely to be low enough to not cause a major problem, but it does add an extra level of complexity to the mix while issuing special votes.

The wider issue remains where this Committee and Council agree that the age should be reduced to 16 years.

There are arguments for and against this.

# Looking at the For Reasons:

By lowering the voting age to 16 for Local Government Elections it involves Rangatahi in politics and helps get them interested in democracy as it is something tangible they can take part it.

While it is disappointing that the Bill is only for local elections and not all elections, it is a great place to start and reflects the importance of all people to have a chance to be heard and influence the election of those who make decisions.

Engaging people early into the experience of voting every three years will help lock in those patterns of behaviour and will help motivate other people to vote.

We are happy to support anything that will help engage more people in the democratic process.

# And Looking at the Against Reasons:

This Bill will not change the political landscape in New Zealand, all it will do is to increase the level of complexity in arranging Council elections. Are 16 year olds equipped to make decisions on who governs their City, but not on who governs the Country or who sells them a beer or wine? It seems to be creating a two tier system, National Government and Local Government where you can experiment.

Key reasons, highlighted again and again for falling involvement in elections relates to the lack of "Civics" education in our schools, there is nothing in the current curriculum that readily prepares students for their duties as citizens and residents of New Zealand and our councils. It is a black box of mystery to so many people. For Local Government the answer for "Why did you not vote?" is often "they don't do anything for me." This is of course wrong, however with limited means to communicate with voters and nothing to start with in terms of civics it is a hard sell, whereas National Government has the luxury of regular coverage across many news platforms.

#### Significance

While the issue of lowering the voting age is a very significant decision, it is one for Parliament to make. The decision to make a submission is not a significant decision in terms of the Policy.

# **Options**

As noted above, there are two options, to make a submission or not to.

If a submission is to be made, then the key decision to be made is whether the submission is in support, against or neutral. Regardless it is staff recommendation to make comments on the two tier age for voting that will affect much of the City.

The final decision is who will be able to approve the submission as it is due on 20 October 2023 and the next Council meeting is on 31 October 2023 unless and Extraordinary meeting is arranged to approve any submission on 17 October.

# **Community Views**

The Community has not been consulted over this, however they will be encouraged to make their views known to the Justice Select Committee via the submissions process.

The Youth Council have been alerted and will make their own decision on whether to make a submission or not.

# **Implications and Risks**

# **Financial Implications**

Making a submission does not have any direct financial implications. However, the two tier age group voting will have a financial consequence for Council as there will be another permutation of the voting papers that will need to be printed for the 16-18 year olds in Invercargill who can vote for Council but not the Trust.

#### **Legal Implications**

There are no legal implications directly for Council, other than part of the submission process.

August was a busier month in the Te Hīnaki Civic Building both at Concierge and the Cashiers. This was mainly due to rates payments and the rates rebate forms for the new rateable year being available. Other media coverage in August included Donovan Park, a Council hearing on a rooster complaint and the oat milk factory.









# Queens Park Shelter Tree Renewal and Fairway Four Realignment

Parks and Recreation Staff have applied themselves well during the winter planting season.

Around 500 shelter trees and native shrubs were planted between golf fairways four and five as part of the fairway four realignment and 1000 shelter trees and native shrubs were planted along Kelvin Street.

A major storm event at the end of the July resulted in the loss of a candle bark gum tree (Eucalyptus rubida) planted in the 1970's in the Australian Border near the car park on Queens Drive.

The park road was closed for a short time while the tree was felled by a contractor.

From external observation there was no obvious indication of potential failure. The clean-up there is largely complete with damaged vegetation programmed for replacement.

A mature pine tree subsequently fell over during the middle of the day near the duck pond. It was noted that the soil around the upturned root ball was very wet and it is likely to have contributed to the failure.

Seven other trees in the area were removed during the immediate clean up as they were within the group or were significantly damaged.

The tree that fell and one other were identified as from those intruding into the airspace above Queens Park.

There was damage to the pond edge, paving and other vegetation.

A planting plan for the area has been developed to ensure a number of slow growing specimen trees will grow to become stately heritage or legacy trees over time.

#### Venue Booking System Update

#### Southland Museum and Art Gallery

The reconstituted Southland Museum and Art Gallery Trust Board have met for the first time. They appointed Rev. Evelyn Cook as interim Chair. This will be reviewed at a subsequent meeting. The Board visited the closed Southland Museum and Art Gallery building.

#### Relocation of the Collection – Level 3 to Level 2

As shelving currently located on Level 3 is to be reused at Tisbury; the collection has begun to be transferred to Level 2 and the Ground Floor. Space was made available through the relocation to the Temporary Off-site Storage facility.

The plan for the relocation will involve the allocation of shelf numbers on pallets; wrapping for freezing and pest control; and signing off the material – depending on whether it will be transported by the Museum staff or the contractor.

This work will be completed by 29 September to enable ABL to begin to remove the shelves from the first week of October.

#### **Relocation to Tisbury**

The project plan which has been developed by the Museum staff, Stephen Cook and RCP continues to be refined in anticipation of the relocation which will begin in December 2023.

The team have a target date of 4 December 2023 to have collection prepared; and at that point work on the dismantling of the workshop and offices will also begin.

Splash Palace also hosted many high school netball teams who were in Invercargill for a tournament. These teams participated in hot and cold recovery sessions and general recreational use of the pools.


#### **Participation and Visitor Stats**

#### Café and Retail



Splash Palace is seeing slow growth in retail sales with the 23/24 monthly average being 2% higher than the 22/23 monthly average.






# **Library Visits**



Visitor numbers have remain steady with 40,275 visiting in August 2023.



# **Library Circulation**



Circulation of in August 2023 (48,878) was slightly less than the previous year (48,998) by 120. The major changes have been the continued increase in digital circulation and in the physical collections an increase in the circulation of DVDs possibly brought about by the closure of United Video in South City. This increase was by nearly 17% over the same period for the previous year. This has been offset by the continued decline of the circulation of music CDs and a review of this collection will be undertaken by the end of the financial year.

### **Digital circulation**



Digital circulation for August 2023 was 4,400 which is the largest monthly circulation since we began providing this service. Dunedin Library have recently added over 6000 items to the Borrowbox platform increasing the amount available for loan to 23,847 for all consortia member libraries which includes Invercargill.



Also included in this application is the newspaper "The digger: official organ Invercargill Returned Soldiers' Association" which the Library holds from March 1920 to January 1921. The budget for this is \$22,402 (excluding GST) with the National Library providing 50%.
