4. Presentation from Project Lead

Ms Amundsen took the committee through a verbal presentation, she thanked the committee for the opportunity to take on this role. Keen to understand from the committee what they would like to see from the project. Visited the Wheelhouse Project

- good place to start is connection and communication. Work with mana whenua and how work together in the future.

Cr Broad talked about joining the puzzle pieces to together - without doubling up.

Mr Hughes noted that he had had an approach to be involved, central government are interested.

Ms Domigan keen to bring the people that were at the conference bring them back in and up to speed with the project. Key that we work with and involve mana whenua.

Cr Greaney keen to see the good work done and turn it into something tangible. Such a big project – condense and prioritise key actions so that we can focus on. Also need to be clear about what not in scope – look at both sides.

Cr McPhail key for him is connections – connect the whole region as one and again tie in the people that were involved early on.

Mrs Coote also agreed not going to wide and look at what is in scope and what isn't. Be clear around what that pou looks like and focus – take the information from the workshops. Need to ensure benefits for our communities and Maori and it is a safe place, otherwise won't get engagement.

The group talked about what success looks like and how we measure that.

RSLG is very interested in this platform due to labour force – a lot of interest in what will be and come out of this.

Ms Suter we do need to support on the milestones to MBIE have been good work done in the workshops – next couple of months are key and laying the groundwork for an online platform. Also how we deliver and involve the whole region.

One big map – pulling into key themes and thinking.

Ms Suter queried how the committee would like Becs to report in.

Ms Amundsen noted that logically a report but also keen to meet with the members of the committee in the next couple of weeks and connect with their communities.

Mrs Coote perhaps once a fortnight, Becs could update the committee on what she is doing and what she needs – perhaps fortnightly on zoom/team and in person in the next two weeks.

The committee agreed that that would work well.

Cr Greaney felt that we need to have a round-up of the information and get the committee on the same page and look at how we support Becs in her role.

Ms Amundsen noted that one of her first things is to do a one pager to leave with people.

Cr Greaney also noted that in Te Anau there are new people that had not been involved in the early stages and would be good to connect with them.

Ms Suter noted that there is a Lets Talk Connected Murihiku page and that is a god resource and can keep as long as needed. Paper in the first meeting would be good to have as well. Formal presentation from Becs once has been able to disseminate that information.

Mrs Coote noted that could be shared to tell the story, and asked Ms Amundsen how she would like to be supported.

Ms Amundsen agreed fortnightly catch ups would be great and getting a feel from the committee what's happening in the community – may be nothing to report but still good to have. The success of this project is how we will get buy in from community groups and organisations, and that's a team effort.

Mrs Coote noted there is a combined runaka meeting on 4^{th} November and will get an invite to Becs for that.

Cr McPhail noted that a one pager report would be good to take back to his council.

Ms Suter showed the group the page that is currently on ICC website – will be good when have our own. Bios from council and mana whenua reps to add to the site would be great to add. Can run polls, video engagements – and noted that Becs can add to this platform for as long as it is needed.

Review of Project Plan

Review the Connected Murihiku Project and Project Plan:

The attached one page summary includes elements of project not detailed in this report.

The milestones for the next MBIE report are due 20 April 2024 and are as follows:

- Report to the JTP team and the Regional Public Service Sector Lead
- Content creator appointed
- Web developer appointed
- Connected Murihiku platform developed
- Engagement hui commenced
- Funding applications developed

This is followed by a launch of the platform on 1 June 2024.

Review:

This review of the Project Plan considers how to progress the Connected Murihiku Project. It also considers how the process to undertake this Project can align with community-led principles and the values of Connected Murihiku.

Better connection and communication across the sector was a strong and repeated message throughout the engagement process and informed the development of this Project. The initiative - Connected Murihiku - is a means to bring together agencies, organisations and people to help alleviate this issue, build resilience and ensure we get the best out of all the community and social activity in Murihiku.

What is clear is there is a large amount of good work happening in the community space across Murihiku Southland. The opportunity lies in connecting it together and intentionally focusing on building a stronger network of organisations across the region.

The review finds that this Project will be able to add value to the community and social sector across the region. Across Aotearoa entities of varying kinds support the social and community sector as Connected Murihiku intends to do. The key to the success of these entities is finding the best way to support the sector and this is best done through using a community-led approach.

As outlined in the project proposal, the focus of this initiative is connection and communication for community and social sector organisations. As such, the keys to the success of this project will be:

- Using a community-led approach to inform how the platform will look and what areas should be the focus
- Using a community-led approach to find the gaps and needs Connected Murihiku can best support
- Identifying the activity already happening in the sector that can be supported through Connected Murihiku
- Developing insights into the sector
- Ensuring a regional approach
- Sharing stories and creating visibility of the social and community sector
- Encouraging and supporting collaboration, networking and connection
- Identifying opportunities to share resources and for capability building

The main area of concern raised is that Connected Murihiku will try to take over activity already being undertaken. As noted above this is not the intention, the intention is to support and enhance existing activity and work where there are gaps and needs not being met.

Another area to be aware of is the regional reach of this project. As part of the engagement plan this will be a focus to ensure Connected Murihiku is regional in its focus. This will include regular engagement with people and organisations in the wider region.

The review finds that achieving the MBIE milestones as agreed and noted above is achievable and below notes the key steps to make progress towards that. The key steps are developed with the milestones, Connected Murihiku values, community-led approach and key success factors in mind.

The following key steps provide the framework for activity until the end of the current financial year.

Key Steps 2023:

- Reconnecting with those connected with throughout the process and reaching out to others to grow the network.
- Gather insights and grow the picture of what is already happening in the community.
- Set the hui date for 30 April 2024 and send initial information.
- Complete an engagement plan including a regional focus
- Complete a communications plan
- Develop a funding plan for 2024/25 year
- Identify how Connected Murihiku demonstrates its values including a cultural capability plan.
- Purchase the Connected Murihiku domain name and start using @connectedmurihiku email address.
- Develop a brand for Connected Murihiku
- Raise the profile of the Project invite the sector to talk about what they are doing and commission articles related to these narratives such as an inspirational person, an amazing project, a great resource, or an activity that is not well known. This can bring visibility in the short term but can also be utilised as future content for the platform.

Key steps and opportunities January – June 2024:

- Continue activity above
- Send out regular e-newsletters to database
- Undertake engagement, communications as per plans
- Undertake funding applications as per the funding plan
- Bring together information about governance training opportunities in the region to make them more accessible.
- Supporting organisations to work with volunteers is an opportunity where Connected Murihiku can provide support and conversations are already underway.
- Develop the first iteration of the platform as a landing page for the Connected Murihiku Project by June 2024 and migrate content generated to this page.
- Undertake engagement with the sector and use a community-led approach to further develop how the platform should evolve to be of the most benefit to the community and social sector. Gathering insights into what exists within the sector, what is working well and adding value, what needs support, where the gaps are and how the sector can be strengthened will provide Connected Murihiku with the best opportunity to add value to the community and social sector.

Joint Committee One Pager:

What: Connected Murihiku is a vehicle to help better connect the community and social sector in Murihiku. The focus of the project is the community and social sector (as opposed to the community at large).

We acknowledge that within the sector work is happening to support better connection but this is largely within segments of the sector eg youth, rural, and migrants. This project is not to take over this work but to bring all this work together, to identify opportunities and gaps and create a solid foundation to support the whole community and social sector.

Why: If the community and social sector are better connected they will be more resilient. A lack of communication and connection across the sector was one of the areas identified through the Strong Communities process as a significant gap. A better-connected sector has a stronger voice and can better advocate for itself and the community. It will also provide opportunities to work together more and identify areas where more support would be helpful.

How: Using community-led principles, Connected Murihiku will begin with a Project Lead who will continue the work done through Strong Communities Murihiku. This will include:

- Connecting with more people in the community and social sector across the region
- Identifying how the sector can be better connected and supported
- Arranging in-person hui for the sector as a whole and where applicable parts of it
- Distributing information to the sector through e-newsletter and the Lets Talk platform
- Strengthen relationships with Māori
- Establish a Te Tiriti based co-partnership with mana whenua and communities to drive this mahi

These things will be quick wins for the project and will keep the momentum going from the SCM work, create visibility and broaden the reach of the Project especially in terms of understanding what is happening already and what the gap is that can be filled through this Project.

In response to these actions, this will lead to better understanding of how to:

- Development of a snapshot of the sector across the region
- Establish an online platform for connecting the sector providing what the sector needs
- Identify opportunities to share skills, training, support and mentoring
- Collaborate better across the sector
- Achieve better outcomes for the community
- Create visibility of the sector

This will create buy in to this project and ensure that what is created fills the gap and need as experienced by those in the community and social sector. It also ensures we follow the community-led principles as identified as priorities through the Project.

Outcomes for the Community & Social Sector from the Connected Murihiku project:

Better connection and communication, therefore more informed

More opportunities to learn from each other and share resources

Easier to identify emerging issues in the community
