1. Apologies

Cr Soper and Cr Menzies Mr Geddes for lateness.

Moved Cr Stewart, seconded Cr Phillips and **<u>RESOLVED</u>** that the apologies be accepted.

2. Declaration of Interest

3. Minutes of the Southland Regional Heritage Committee Meeting Held on 19 October 2023

Moved Rev Cook, seconded Cr Reid and <u>**RESOLVED**</u> that the Minutes of the Southland Regional Heritage Committee Meeting held on 19 October 2023 be confirmed.

4. Financial Reports for Southland Regional Heritage Committee A5079033

Mrs Simmonds presented the report.

Mrs Simmonds noted that the fund allocated for Heritage South in 2023 had not yet been uplifted, the Committee agreed that Heritage South could use the 2023 allocated fund for 2024.

Mrs Simmonds requested the Committee approve the payment of \$5,500 to the Tuatapere and District Promotions Inc-Central and Western Archive, Murihiku Southland.

Moved Rev Cook, seconded Cr Stewart and <u>**RESOLVED**</u> that the Southland Regional Heritage Committee:

- 1. Receives the "Financial reports for Southland Regional Heritage Committee".
- 2. Receives Funding Report from 1 September 2023 to 31 January 2024 (Appendix1).

Mrs Simmonds noted forecasted costs of \$330,000 for the 2025-2026 year were allocated for resource team/contractors, and this was the main change in the forecast.

Mr Marriott noted a possible reduction of the Lotteries Grant for Project Ark. New Zealand Lotteries Grant Board – Environment and Heritage recently issued a general notice on the potential reduction of funds for the sector.

The Committee discussed the potential reduction of the lottery grant for the art sector and noted that this could significantly impact the sector. The Committee discussed sending a formal letter to New Zealand Lotteries Grant Board – Environment and Heritage informing them of the Southland Regional Heritage Committee's opinion on the impacts of reducing the level of funds to the art sector.

In response to a query about the Committee's delegation on this matter, Mr Morris said that the Committee had the power as this Committee was established as a Joint Committee of the three councils, and the matter fitted within the Committee's subject area. Further, he said it would be an additional help if the Committee could get support from the three councils and also the four Rūnaka. The Committee decided to seek support from local MPs and also from the Creative Communities Fund Committee. In conclusion, the Committee agreed to refer this matter to the Mayoral Forum to get support for a joint letter or separate letters on this matter.

Moved Cr Ludlow, seconded Rev Cook and <u>**RESOLVED**</u> that the Southland Regional Heritage Committee:

- 3. Receives the Project Ark Budget vs Actual 2023-2024 as at 31 December 2023 (Appendix 2).
- 4. Receives Project Ark Forecast 2023-2024 and 2024 2034 Long-term Plan (Appendix 3).
- 5. Approves writing a letter to Lotteries regarding the reduction of funds for the art sector and refer to the Mayoral Forum to seek support from the three councils.

- 6. Approves the payment of \$75,000 for the Roving Museums Officer position for the next three years.
- 7. Approves the payment of \$5,500 for the 'Tuatapere and District Promotions Inc-Central & Western Archive, Murihiku Southland'.
- 8. Approves changing the allocation uplift year from 2023 to 2024 for the \$5,000 grant allocated for 'Heritage South towards the proposed 2023 annual training opportunity'.

5. The Southern Regional Resources Project A5143939

Mr Marriott spoke to the report. It was noted that the Lotteries grant might not provide the same level of funding as previously funded for the same project. Therefore, a name change was proposed for the project.

It was noted that there were two vacancies in the Project Ark team. After the confirmation of the fund these positions would be recruited.

It was noted the Project Ark team was currently based at Te Pataka Taoka – Southland Regional Collection facility. It was planned to provide support to small museums across Southland.

It was noted that a photography team needed to return to Te Hikoi Museum at Riverton to complete some photographic work.

It was noted that resolution 6 of the report allowed officers to submit funding applications to other sources of funding, such as electricity companies and the Getty Fund.

In response to a query about the Getty Fund, Mr Marriott said that the Getty Fund supports Toaka Māori collections and art collections conservations.

It was highlighted that the proposed regional resource project would bring additional expert support for museums across the region. There were plans to bring a textile expert into the team.

The Chair proposed amending the project name to add the word 'Heritage'; therefore, the name should be 'The Southern Regional Heritage Project', and the team name should be 'Southern Regional Heritage Resources Team'.

A question was raised about the naming conventions in relation to government practices; the Chair noted that the Committee had the authority to rename this project, and the Committee would be honoured to have a gifted name from four Rūnaka.

A query was raised that, after the review of the Heads of Agreement between the three councils, it could result in establishing a different entity; therefore, where would the obligations sit if the Committee approved the funding for the project at this stage. Mr Morris said that if the review of the Heads of Agreement resulted in establishing a new

entity replacing the Regional Heritage Joint Committee (SRHC), the new entity would be obliged to continue the decisions of SRHC.

Moved Rev Cook, seconded Cr Phillips and <u>**RESOLVED**</u> that the Southland Regional Heritage Committee:

- 1. Receives the report "The Southern Regional Resources Project".
- 2. That the SRHC agree to rename the Project The Southern Regional Heritage Resources Project and the Team Southern Regional Heritage Resources Team.
- 3. That the SRHC agree to invite the four Rūnaka to consider providing a name for the Project and the Team.
- 4. That the SRHC agree to support a Regional Resources Project until 30 June 2026, and agree to commit up to \$548,636 to the Project.
- 5. That the SRHC agree to support an application to the NZ Lottery Grants Board to seek funding support of \$275,000 for the Regional Resources Project.
- 6. That the SRHC agree to endorse additional applications for funding to external funders of up to \$200,000, including, but not limited to, Ministry of Culture and Heritage; Stout Trust, Getty Trust for additional financial resources towards a Regional Resources Project.

6. Review of Committee Heads of Agreement

The Chair noted the importance of the three councils' involvement in reviewing the Committee's Heads of Agreement.

In response to a query about the availability of council staff to conduct the review, Mr Morris said that if the Committee decided to proceed with that option, officers would work on it, but it would bring additional pressure; therefore, he preferred a third-party review.

In response to a query about the budget for the third part review, Mr Morris noted that the Committee could set a budget for the review. The budget would depend on the number of experts involved. The cost would be less if the Committee could find experts in the region and noted the Committee had sufficient funds to cover the costs.

It was noted that the process of selecting a third-party reviewer required some form of transparency.

After gathering information, a budget for the review would be reported back to the Committee to approve. The approval may be sought via email or through an extraordinary meeting as it depended on the level of the budget required.

Moved Cr Ludlow, seconded Cr Stewart and <u>**RESOLVED**</u> that the Southland Regional Heritage Committee:

7. General Business

Collection Relocation

Mr Marriott noted that the Collection of the Te Pataka Tiaki Toaka – Southern Regional Collections Trust was successfully relocated to the Te Pataka Taoka – Southern Regional Collections Facility.

Vinegar Syndrome

Mr Marriott noted that Vinegar syndrome was identified in one of the photographic collections in the collection of the Te Pataka Tiaki Toaka. This Collection includes 1,500,000 negatives. Vinegar syndrome could be spread and could be controlled by keeping the collection in cold storage. The work is in progress to get the best professionals to resolve the situation and digitise the collection.

Promotion of the Southland Regional Heritage Committee (SRHC) Fund

Mr Morris noted that the SRHC Fund information and fund applications could be found on the Invercargill City Council website. The Chair noted the importance of promoting the SRHC fund through council websites.

Purpose and Summary

To present to the Committee the Southland Regional Heritage Committee Funding Report – 1 February 2024 to 30 April 2024

Recommendations

- 3. Approves the Interest earned for the past six months to be release into the operations account.
- 4. Approves the rollover of \$400,000 term deposit for a further six months to 31 December 2024.

Funding Report – 1 February 2024 – 30 April 2024

The funding report has a total closing balance of \$545,239.24 of which \$400,000 remains on Term Deposit.

You will note that as part of the Forecast Statement under Administration Fund there is an allowance for a further three year's funding for the Roving Museum Role. This is to coincide with the funding being sourced from CTOS.

There are outstanding costs for Project Ark totalling \$232,043. This amount is for Quarter one to three costs.

Interest earned over the period of \$11,051.71 has been reflected in the operations account and it is recommended that the Committee approve this treatment.

Term Deposit

Currently \$400,000 is invested on term deposit which matures on 30 December 2024. The term deposit funds are not needed to meet the forecast expenditure to 30 June and it is recommended that it be reinvested for six months. Based on current rates the indicative rate it will be invested at is 6.15%.
