Purpose and Summary

Council has received a request for temporary road closures for the Southland Santa Parade 2024, to be held on Saturday, 30 November 2024 with an alternative date of Sunday, 1 December 2024 if the weather is unsuitable.

This is a yearly event in Invercargill city, and with well organised traffic management will not unreasonably impede traffic in these areas.

Council is being asked to consider utilising its powers under Local Government Act 1974 (Section 342 and Schedule 10). This Act allows Council to close a road for an event (after consultation with the NZ Police and Waka Kotahi) which it decides will not unreasonably impede traffic.

Recommendations

That the Infrastructure and Projects Committee:

- 1. Receives the report 'Temporary Road Closures Southland Santa Parade 2024'.
- 2. Resolve that the proposed event outlined in the report will not impede traffic unreasonably.
- 3. Approves the temporary road closures for:
 - Gala Street from Doon Street to Dee Street from 11.00am until 3.00pm on Saturday, 30 November 2024 weather permitting with the alternative date of Sunday, 1 December 2024

as permitted under the Local Government Act 1974 (Section 342 and Schedule 10).

Background

On 24 October Council received a request from the Southland Christmas Parade Charitable Trust for the following road closures:

Gala Street	From Doon Street to Dee Street	Saturday, 30 November 2024	11.00am until 3.00pm
Kelvin Street	Victoria Avenue to Yarrow Street	Saturday, 30 November 2024	12.00pm until 3.00pm
Yarrow Street	Kelvin Street to Dee Street	Saturday, 30 November 2024	12.00pm until 3.00pm
Spey Street	Leven Street and Dee Street	Saturday, 30 November 2024	12.00pm until 3.00pm

The Local Government Act 1974 Section 342 allows Council to close a road for an event (after consultation with the NZ Police and Waka Kotahi New Zealand Transport Agency), which it decides will not unreasonably impede traffic. Consultation with the public under this legislation is not required.

This event will have minor impact on traffic movements for approximately 4 hours, but is a premier event for Invercargill.

Good traffic management will be provided. With the location of these events, there are no options of alternative routes available.

A request has been made to the NZ Police and Waka Kotahi and they have no objection to this event.

Issues and Options

Analysis

This event will create disruption to traffic flows. The event organisers have proposed an amended parade route for the 2024 event, using Gala Street, Kelvin Street, Yarrow Street, Dee Street (SH6), and return to avoid a council 3 Waters worksite at Leet Street and Dee Street intersection. As per the 2023 event, this parade route will allow the prompt opening of Trooper Memorial roundabout to allow SH1 traffic to return to normal as soon as possible.

The closing of the street is necessary to allow the event site to be set-up on the day of the event. The closure will also assist the event organisers to provide appropriate safety of the set-up staff, participants and general public at this event.

Significance

This request is not significant in terms of Council policy.

Options

The options which exist are to approve or decline the request. The street planned to be closed is seen as appropriate to effect a safe area for the activities.

Community Views

This legislation does not require community views to be sought however this is a public event which has been held in Invercargill for approx 25 years.

Council staff are working through the health and safety risks that may arise as a result of overlapping PCBU duties.

If these closures are approved, the event organisers will be advised and a traffic management contractor engaged by the organiser. A public notice would be published in a local newspaper and information posted on the ICC website.

Purpose and Summary

Council has received a request for a temporary road closure for the Great South – New Year's Eve on Don Street to be held in Don Street on Tuesday, 31 December 2024, 4.30pm – 12.00am.

This event is a repeat of the 2023 New Year's Eve family friendly event which was supported by the community, with well organised traffic management that does not unreasonably impede traffic around the closure area.

Council is being asked to consider utilising its powers under Local Government Act 1974 (Section 342 and Schedule 10).

This Act allows Council to close a road for an event (after consultation with the NZ Police and NZTA) which it decides will not unreasonably impede traffic.

On 1 November 2024 Council received a request from the City Centre Coordinator at Great South for a road closure of Don Street between Kelvin Street and Dee Street on Tuesday, 31 December 2024 from 11.00am until 12.00am for the event to be held from 4.30pm until 10.30pm.

The Local Government Act 1974 Section 342 allows Council to close a road for an event (after consultation with the NZ Police and Waka Kotahi New Zealand Transport Agency), which it decides will not unreasonably impede traffic. Consultation with the public under this legislation is not required.

This event will have minimal impact on traffic movement.

Good traffic management will be provided and the city grid roading network, there are alternative routes available.

A request has been made to the NZ Police and NZTA for support of this closure, and we are not expecting any objections. The event does not impact State Highway 6 – Dee Street.

This event will create only minor disruption to traffic flows. Business access will be managed by the event organisers. The closing of the street is necessary to ensure appropriate safety of participants in this community event.

Great South and Invercargill City Council are partnering with Nightlife DJs to create a New Year's Eve event on Don Street on Tuesday 31 December 2024, from 4:30pm until 10:30pm. This will require the closure of Don Street between Dee Street and Kelvin Street between the hours of 11:00am and 12:00am midnight to allow for the safe set up, delivery and pack down of the event.
