

Looking after your street frontage



What you need to know...

Maintain your property frontage by mowing lawns, and trimming hedges and trees to enhance street appearance and ensure footpath safety. Because Invercargill City Council doesn't rate for frontage maintenance property owners are asked to include grass frontages or rural ditches in their regular property upkeep.



Trees and shrubs - trimming

Property owners are asked to keep trees and shrubs trimmed to prevent hazards on footpaths, particularly for mobility scooter users, and maintain clear sight lines at street corners and entrances. Before digging or planting on street verges, you must obtain Council permission as electricity and telecommunication cables run along property boundaries. While street beautification is encouraged, damaging these services is dangerous and expensive to repair.

Paving of frontages

are required to pay for this work.

Property owners who wish to have their frontage paved may apply to Council for permission. However, property owners

The Council's Parks Department is responsible for planting and maintaining all street trees and shrubs.



If you have any concerns about these plants, please contact the Parks Department directly. You can also reach out to request a tree for your street to help enhance the beauty of your neighbourhood.

Gravel on frontages



Gravel and large stones are not permitted on frontages as a landscaping material because they can become dislodged and scattered onto footpaths.

This can potentially cause injury to pedestrians, particularly the elderly and people using mobility scooters.







Landscaping of frontages



Landscaping of frontages in urban and rural areas may be permitted, however each situation is

Rural Frontages

In rural areas, property frontages can be very different to those in urban areas. Verges may be large grass areas, ditches, and watercourses. In areas such as Ōtātara, the verge may have native bush growing with no well-defined boundary.



Council maintains all culverts under roads for watercourses and some piped networks. If you live in a rural area where drainage is not rated for, you are responsible for maintaining ditches to ensure they are operational and kept tidy.

Council does permit grazing of frontages in rural areas, however, you must apply to Council and follow some sensible safety rules.

Property owners are responsible for maintaining any roadside bushes that extend from their property. These bushes should be trimmed to ensure clear visibility for motorists and to keep a safe distance from the road edge for pedestrians. When planting near the boundary, please ensure that vegetation does not interfere with overhead power lines.

DID YOU KNOW...

Your property frontage may contain important service connections, such as water, stormwater, and sewer pipes linking your home to the street mains. Additionally, the street frontage often contains underground and overhead utilities, including electricity and telecommunication cables, water tobies, manholes, and fire hydrants.



For this reason, special permission from Council is required before anyone can excavate or dig in the road or verge area. This helps protect essential services and ensures that all work is carried out safely. Please note that "House for Sale" signposts must not be driven into the frontage, as doing so could damage underground cables or services.
